She enrolled with limited English and academic skills and has progressed so much that she now helps others in her classes. In addition to her academic classes, she attended our parenting education classes and developed her skills as the first and most important teacher of her sons. Cristian and Erick have benefitted from our early childhood classes and SIZZLE!®, ProJeCt's summer literacy camp. As Ofelia advances her English and works toward a GED, her sons will enter school with the English and development skills they need to thrive in school.

MARY ZAMORA

Alumni - Long Term Impact

Mary graduated from ProJeCt's Success Academy in 2018-2019 after facing some struggles in her past efforts. After graduation she enrolled in Northampton Community College to work toward a nursing degree and earned a 4.0 GPA in her first semester! COVID shut down her classes in March and with balancing extra work hours, two children schooling at home, and a work injury, she had to take a break from her college studies. With encouragement from ProJeCt staff, she returned to school in summer for an online class. She struggled with remote learning, but she is ready to return to classes full-time when the college opens again. She currently works FT at Moravian Hall Square and because of her success in achieving her GED at ProJeCt and her success at NCC, she earned a \$1,000 tuition scholarship from her employer.

TETIANA SIDEK

GED Graduate and Volunteer

Tetiana graduated from ProJeCt's Success Academy in January of 2020. She was incredibly committed to her education, achieving a high attendance rate of 95% and was very active in class. After graduation she worked diligently to earn her Microsoft Office credentials and completed them all. She is seeking employment and has met her goal of getting a driver's license. She has also taken the time to gain experience and give back to ProJeCt as a volunteer in our Student Success Program.

DAVID ORTIZ

ESL and IET Graduate

David started at ProJeCt's Success Academy in August of 2019. He began in our Intermediate/Advanced class and participated in an Integrated Education and Training class. When COVID hit, he was scared of transitioning to online learning, but with assistance from ProJeCt staff he became very comfortable and completed his ESL education and IET. He is now interested in furthering his education by taking GED classes. David has also received support from ProJeCt's emergency ASSIST program, enabling him to stay on course and focused on advancing himself educationally and economically.





CLIENT SERVICE EXPENSES BY PROGRAM


